

**City of Dallas Liability Release, Assumption of Risk Agreement,  
Covenant Not to Sue and Contact Information**

I, \_\_\_\_\_, hereby affirm that I am aware that physical activities held at Dallas City Hall have inherent and unforeseeable risks that may result in serious injury or death. I understand and agree that the City of Dallas and any of its respective employees, officers, agents, contractors or assigns (hereafter referred to as "Released Parties") may not be held liable or responsible in any way for any injury, death or other damages to me, my family, estate, heirs or assigns that may occur as a result of my participation in any activities (hereafter referred to as "activities held at Dallas City Hall") or as a result of the negligence of any party, including the Released Parties.

In consideration of being allowed to participate in activities held at Dallas City Hall, I hereby personally assume all risks of activities held at Dallas City Hall—whether foreseen or unforeseen—that may befall me while I am participating in these activities. I further release, exempt and hold harmless the Released Parties from any claim or lawsuit by me, my family, estate, heirs or assigns arising out of my participation in activities held at Dallas City Hall. My heirs, successors, assigns and I hereby forever release and discharge the Released Parties—in both their public and private capacities—from any and all actions, causes of action, claims, demands, damages and costs on account of, or in any way growing out of, any and all known and unknown, anticipated or unanticipated, personal injury, death and property resulting or to result from participation in activities held at Dallas City Hall. My heirs, successors, assigns and I further agree and covenant—for the consideration described above—never to file any claim, lawsuit or other proceeding—whether judicial or administrative—against the Released Parties for any personal injury, property damage, wrongful death or other injury suffered by me that may arise or result from my participation in activities held at Dallas City Hall.

I agree to abide by the rules and regulations of the City of Dallas while participating in activities. I recognize and acknowledge that the City makes no representations or warranties—expressed or implied—as to the nature and hazards or absence thereof of activities held at Dallas City Hall.

I further state that I am at least 18 years of age \_\_\_\_\_ (initial) and legally competent to sign this liability release. I have carefully read the foregoing document, and know and understand the contents thereof. I sign this release voluntarily as my own free act with full knowledge of its significance—intending to be legally bound thereby. I further agree if any provision of this Agreement is found to be unenforceable or invalid, that provision may be severed from this Agreement; however, the remainder of this Agreement shall then be construed as though the unenforceable provision had never been contained therein.

**BY THIS INSTRUMENT, I AGREE TO EXEMPT AND RELEASE THE CITY OF DALLAS AND ALL RELATED ENTITIES AS DEFINED FROM ALL LIABILITY OR RESPONSIBILITY WHATSOEVER FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH HOWEVER CAUSED.**
